### Light Recycle Washington Program:

January 1st 2015

Fluorescent Tube (up to 8 ft), CFL (Compact Florescent Lights) HDI (high Density Lights) Sold in Washington State can be dropped off at the landfill. Limit 10 per day Business' too!

**Flow Control:** It is unlawful for any collecting agency or other person to deliver or deposit any solid waste generated and collected within the county outside the borders of Whitman County, or within the county except at a "designated facility."

Designated facilities are the Whitman County Carothers Road Solid Waste Facility and any county-owned transfer station.

## Your County Transfer Station & Landfill

Carothers Road Site:

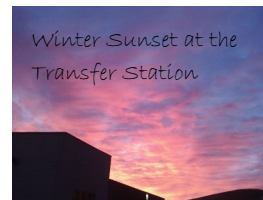
Construction of a sanitary landfill on County owned land along Carothers Road between Colfax and Pullman began in 1974 and Completed in August of 1975.

A scale house was added in 1978, landfill accounts were computerized in 1987. The landfill was closed and export of MSW to a regional solid waste disposal site began in 1993.

Since 1993 concrete, asphalt, and other demolition waste has been land filled. A recycling operation with a drop-off center for recyclables was also included.

In 1995 a center to receive and process disposal of household hazardous waste was added to the Whitman County Carothers Road Solid Waste Facility. Yard wastes and lumber are also accepted at the Whitman County Carothers Road Solid Waste Facility. This material is ground and repurposed.

Spring of 2014 ground was broken on a new Transfer Building that was up and running jUNE of 2015. The old transfer building houses the Recycling Program for Whitman County.

**Permitted Demolition:** Inert materials brick concrete, asphalt roofing etc. No drywall or garbage items. \*Each load must be inspected by a Landfill employee before unloading.  
 Min. Charge up to 400 lbs. \$15.00  
 \$75.00 /ton

**Wood Waste:** Milled lumber including plywood, OSB boards. Some nails and paint may be accepted. NO treated wood ie: railroad ties or pressure treated.  
 Min. Charge up to 1140 lbs. \$15.00
